**COAST GUARD INTELLIGENCE BADGE**

**I. PURPOSE:**

This SOP sets forth the objectives, guidelines and procedures in wearing the Coast Guard Intelligence Badge by deserving personnel.

**II. OBJECTIVES:**

1. To recognize expertise acquired by PCG and other Law Enforcement Agencies (LEAs) personnel through training, accomplishment and assignment in the CGIF.

2. To emphasize operational capacity and special merit that characterizes the members of the CGIF.

3. To provide policies, guidelines and procedures in wearing the Coast Guard Intelligence Badge.

**III. APPLICATION:**

This SOP shall apply to all PCG Uniformed Personnel and Civilian Agents whom by virtue of qualification prescribed in the following paragraphs are eligible to receive corresponding badge in recognition for their acquired expertise.

**IV. DEFINITION OF TERMS:**

For the purposes of this SOP, the following words and phrases shall be defined and understood as hereunder indicated:

**A. Badge** – are awards based on the prescribed requirements as stated in approved Circulars, SOPs and other publications.

**B. CGIC** – acronym for Coast Guard Intelligence Course. Intelligence Course offered by CGISTF.

**C. CGIF** - acronym for Coast Guard Intelligence Force.

- D. **CGISTF** – acronym for Coast Guard Intelligence and Security Training Facility.
- E. **Civilian Agents** – regular civilian agents who are involved in intelligence/counter-intelligence operations for the accomplishment of maritime law enforcement.
- F. **Intelligence Authorities** – Major agencies which have Intelligence schools – PNP, AFP, PCG, etc.
- G. **Intelligence Schools** – schools which offers Intelligence Course – Philippine National Police (PNP), Armed Forces of the Philippines (AFP), Philippine Coast Guard (PCG), etc.
- H. **PCG Uniformed Personnel** – regular member of the Philippine Coast Guard in the active service under the Department of Transportation.
- I. **Training** – is a continuous process where Coast Guard personnel undergo classroom and field training to ensure competence and proficiency in the performance of intelligence and security operations.

## V. **COAST GUARD INTELLIGENCE BADGE**

### A. **GUIDELINES:**

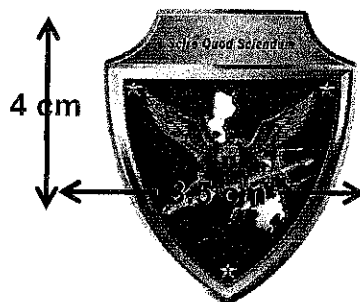
1. **To Whom Awarded:** To any Officer and Enlisted Personnel by the Major Services only after completing the basic requirements prescribed by Intelligence authorities and after graduating from the Intelligence Basic Course offered in the Major Services Intelligence schools, and graduating from Coast Guard Intelligence Course conducted by the Coast Guard Intelligence and Security Training Facility (CGISTF), and personnel who served at least two (2) years of service in Intelligence Community.
2. **By Whom Awarded:** Deputy Chief of Coast Guard Staff for Intelligence, CG-2.
3. **Requirements:**
  - a. Personnel with special Intelligence training and experience on technical expertise, research and analysis, tradecraft and other special skills.
  - b. Completion of the basic requirements prescribed by the Intelligence authorities and after graduating from the Intelligence Basic Course offered in the Major Service Intelligence schools, and graduating from Coast Guard Intelligence Course conducted by the Coast Guard Intelligence and Security Training Facility (CGISTF).
  - c. Must served at least two (2) years of service in the Intelligence Community.

d. Honorary Badge awarded to deserving personnel as determined by the CGIF Awards and Decoration Board duly approved by DCCGS for Intelligence, CG-2.

#### B. BADGE DESCRIPTION:

- **Eagle** - a symbol of an entity having the character of gathering and transmitting intelligence with might, alertness, and focus near and at distant points.
- **Shield** – aside from manifesting protection from potential enemies, its shape, similar to the tip of the trident, whoever wears the Badge as an intelligence operative, signifies penetration or infiltration against lawless elements or enemies of the state.
- **Three Stars** – as in of the Philippine National Flag, closely situated in every corner of the triangular shield, symbolizes guidance and protection to the three major island groups of the Philippine archipelago.
- **Philippine Map** – illustrates the national responsibility of PCG to enforce its duties and responsibilities.
- **Trident** – held by a firm eagle, symbolizes its piercing ability to possess power and intelligence, and govern over the sea.
- **“Scire Quod Sciendum”** – a Latin phrase which translates to “knowledge which is worth having” denotes the relevance of pertinent intelligence in fulfilling the mandates of CGIF.

#### VI. MANNER OF WEARING:

Coast Guard Intelligence Badge may be worn on White Duck, Service Blouse, MARLEN Blue, Bush Coat, Working Blue and Battle Dress Uniforms. The Intelligence Badge is worn at the center of the left breast pocket below the flap.

A handwritten signature in black ink, appearing to be "J. S. ...", is located in the bottom right corner of the page.

**VII. AUTHORITY:**

The Coast Guard Intelligence Badge shall be approved and awarded only by the Deputy Chief of Coast Guard Staff for Intelligence, CG-2

**VIII. RESCISSION:**

The provisions of any existing rules and regulations, circulars, policies, directives and other publications which are inconsistent with the provisions of this SOP are hereby rescinded, repealed or modified accordingly.

**IX. EFFECTIVITY:**

This SOP shall take effect upon publication.
